Dear Judge Donnelly:

Pursuant to the Court's February 6, 2020 Order, enclosed please find the parties' Joint Proposed Juror Questionnaire (the "Questionnaire") in the above-referenced matter, with the following exceptions to the joint nature of the Questionnaire.

The government has conferred with defense counsel and the parties agree on a substantial portion of the Questionnaire, which incorporates questions proposed by both parties. Defense counsel has advised, however, that it objects to the following questions in whole or in part as indicated:

**Question No. 67:** The defendant objects to the question in part and proposes the following bolded alternative language so that the question is not limited to the topic of a grant of immunity:

One or more government witnesses may testify that they participated in crimes. The witness may have a criminal history and may be testifying pursuant to an agreement with the government immunizing him or her from prosecution. Use of such witnesses is lawful. Do you have feelings about a witness who was granted immunity from prosecution, **or offered or promised anything**, that would make it difficult for you fairly and impartially to consider that testimony or render a guilty verdict based on the testimony of such witness? [] YES[] NO If YES, please explain:

<u>Government's Objection</u>: The government objects to the defendant's proposed additional language as overly broad, vague, likely to cause confusion and unfairly prejudicial. The broadness of the defendant's proposed language requires the prospective jurors to envision scenarios of an unspecified, and likely irrelevant, list of potential items that may hypothetically be offered to a witness.

**Question No. 68:** The defendant objects to this question and proposes the following alternative language:

It is the law that the testimony of a single witness can be sufficient to convict a defendant of a charged crime, if the jury finds that the testimony of that witness established proof beyond a reasonable doubt. Do you have any opinion or belief that would prevent you from applying this rule of law?

Government's Objection: The government objects to the defendant's proposed language to the extent that it is intended as an alternative to Question No. 68, and requests that Question No. 68 be provided as currently drafted. The intended purpose of Question No. 68 is to inquire whether the prospective juror would have any difficulty following the court's instructions regarding witness testimony and the burden of proof for the sole reason that the witness was granted immunity by the government. The defendant's proposed language removes any reference to an immunized witness, rendering it ineffective in its purpose to ascertain the individual's views or prejudice against a witness that has obtained immunity. While a juror is entitled to consider a grant of immunity when determining whether to credit a witness's testimony, it is relevant and proper to inquire as to whether the individual has an unreasonable bias against such a witness that would otherwise make the individual unable to follow the Court's instructions. Notably, the government initially proposed Question Nos. 67 and 68 as a single question consisting of two subparts, (a) and (b). At the defendant's request, the government separated the subparts into two individual questions, but believes they may readily be combined as a multipart question.

**Question No. 69:** The defendant objects to this question in its entirety on relevance grounds and proposes that it be deleted.

Government's Objection: It is the government's position that given that the investigation in this matter involved the execution of one or more judicially authorized warrants, and that the government anticipates evidence obtained as a result of the warrant(s) will be presented at trial, prospective jurors' beliefs regarding such

investigatory tactics by law enforcement are relevant and the question is therefore proper and warranted.

The defendant further proposes that the following questions be added to the Questionnaire, to which the government objects for the reasons stated:

<u>Proposed Question</u>: Have you, a family member, a close friend, or a spouse or partner, ever had a sexually transmitted disease. YES [] NO []. If YES, please explain.<sup>1</sup>

Government's Objection: The government objects to this question in its entirety as overly broad and unduly invasive. Requiring prospective jurors to disclose protected medical information about themselves and others close to them is unnecessarily intrusive. To the extent the prospective jurors' views on sexually transmitted diseases are relevant, the issue of potential bias or other relevant information may readily be ascertained through the less intrusive question proposed by the government, which, as posed, inquires whether the fact that the case involves allegations regarding exposure to one or more sexually transmitted diseases will affect the individual's ability to be fair and impartial and, if so, seeks an explanation. (See Question No. 37).

**Proposed Question:** If you were to be selected to serve on this jury, and you find that the Government has not proven the allegations against Mr. Kelly beyond a reasonable doubt on any or all of the charges, will you be able to render a verdict in favor of Mr. Kelly? [] YES [] NO. If NO, please explain.<sup>2</sup>

Government's Objection: The government objects to this question as overly broad, vague, confusing and duplicative of questions already posed in the Questionnaire. The Questionnaire has multiple questions which inquire about the individual's ability to follow the Court's instructions, particularly as to the burden of proof. (See, e.g., Question Nos. 35, 61, 66, 70 and 72). Moreover, the jurors will be instructed by the Court as to the manner by which they are to render a verdict. In addition, as phrased, the question misstates the law and suggests that a juror would need to render a general acquittal in favor of the defendant if the government failed to meet its burden on "any . . . charges."

The defendant proposes that this question be inserted after or as part of Question No.

The defendant proposes that this question be inserted after Question No. 66.

<u>Proposed Question</u>: With respect to Question Nos. 13, 21, 25, and 26, the defendant seeks to inquire as to the name of the prospective juror's employer, <u>i.e.</u>, the company at which they are employed.

Government's Objection: The government objects to inclusion of any questions in which the prospective jurors are asked to list the name(s) or address(es) of his/her employer(s), or if self-employed, the name of his/her business(es). Moreover, the government objects to inclusion of any questions seeking information about the employers or businesses of the prospective jurors' family members. The government intends to file a motion seeking an anonymous and partially sequestered jury. Accordingly, for the reasons the government will outline more fully in its motion, the government believes that the prospective jurors should not be required to provide their place of employment. We respectfully request that the Court defer decision on this issue until after the parties have had an opportunity to brief the forthcoming motion for an anonymous and partially sequestered jury.

Mr. Kelly is also charged with violations of the Mann Act, including the transportation of individuals, including a minor, for the purpose of engaging in illegal sexual activity, and illegal coercion and enticement of individuals, including a minor, in violation of Title 18, United States Code, Sections 2421(a), 2422(a) and (b), and 2423(a). Mr. Kelly has pleaded not guilty to all of the charges. This is just a summary of the charges to give you some background on the case.
